Motion

That the P&C membership approve the operational spending for 2020 for the P&C, Uniform Shop and Band. For the P&C, this includes spending on insurance, P&C Federation membership, website and technology fees. For the Uniform Shop, this includes payments to the Uniform Shop Coordinator, and the purchase of stock for the uniform shop. For the Band, this includes insurance, ongoing conductor fees, competition fees, instrument maintenance, and band uniform purchases. This approval does not cover contributions to the school from fundraising monies, or other discretionary spending.

Explanation

Technically, all spending by the P&C must be approved by either the Executive (for amounts below \$1,000) or the P&C Membership (for amounts over \$1,000). To ensure all spending is appropriate approved, we propose that operational spending (i.e. that incurred regularly in the ordinary course of business for P&C activities) be approved annually as part of the Annual General Meeting as a standing item. All discretionary spending (e.g. on contributions to the school, or one-off spending such as band instruments) would need to get approval as normal through the P&C Membership or Executive.
